




2020 Registrations and Introductions

North American registrations as a percentage of total annual registrations. Report of the Registrar-Recorders 26 Apr 2021 Page 1 Of the 1115 new registrations, 51.4% are tall beardeds, 35.9% other bearded types, and 12.7% beardless and species or species hybrids. Totals by class are as follows:

Print On Demand continues to work well for printing copies of our publications.

Reserved and Registered Names

On a recurring basis throughout the year a PDF of the then current list of registered and reserved names is being published on the AIS website to better enable hybridizers/registrants to verify that a name they would like to have is not in conflict with a previously approved name. A list of all names registered and reserved in 2020 is currently on the website.

Assistant Registrar/Recorder

Janis Shackelford is being trained in as Assistant Registrar/Recorder and will eventually (within the current year) assume the role of Registrar/Recorder. John Jones and Joanne Prass-Jones will continue to assist her after she assumes full duties.

Sharing the Registrar/Recorder Work Load

John is doing some redesign work on the annual R&I database architecture to enable the workload to be shared by several people. It should be noted that one person (the appointed ICRA) must be responsible for the tasks as lined out by the ISHS ICRA the primary task of which is approving requested names. This task also includes creating the original new database record for each name and verifying/tracking/managing payments for registering or reserving names. Entering descriptions and parentage information will be done by others as that is generally outside the scope of the ISHS requirements.
