THE TREASURER'S REPORT TO THE BOARD

This report breaks from the custom of presenting a six month report at the National Board Meeting. I am reporting for seven months so that we may have more up to date information to analyze our financial situation. Because of timing, I believe the only items missing are the April Storefront figures and the Registrar income and expenses. These will be in the complete Annual Report.

My best estimate projections for the total fiscal year (based on income and expense for this year to date plus the amounts from May 1st last year minus the umbrella policy and \$10,000 in membership expenses) are income; \$162,000, expenses of \$187,000, giving us a deficit of \$25,000. Major decisions will have to be made so that we do not have to access too much of our reserve funds. Hopefully, the rate increases we voted on last fall will help the rest of the year but most will probably not start helping until next year.

Interest rates on both our investments and operating funds have held steady this year. Although CD rates are low, our present CD's give us an average rate of approximately 4.25% on our investments. I continue to keep abreast of Money Market rates and move funds around to earn in the 1.5-2% range. Managing money in today's market continues to be a real challenge. I shall continue this job in the best interest of the Society. Our current Certificates of Deposit are:

\$25,000 at State Farm Bank maturing 3/25/2006 at 3.2%
\$25,000 at State Farm Bank maturing 3/25/2006 at 2.710%
\$50,000 at Savings Bank of Mendocino County maturing 3/12/2008 at 4.27%
\$25,000 at Discoverer Bank maturing 10/31/2006 at 4.75%
\$25,000 at Discoverer Bank maturing 1/23/2007 at 4.8%

After serving for seven years as your Treasurer, I have tendered my resignation effective September 30, 2005. It is best for both myself and the Society that a new person take financial control. I have enjoyed my term greatly and especially all of the wonderful people I have met and worked with. I feel I have had a major part in bringing AIS from a negative financial position to where our reserves stand today. I also computerized the financial records so the switch to your new Treasurer will be smooth. This gives me great satisfaction. I am not going off into the woods and will try be available to help AIS in the future when needed.

Thank you for your confidence in me by allowing me to continue as your Treasurer. It is with both joy and sadness that I will be leaving you.
