The 2009 Check List has been published in both softcover and hardcover versions. It was not without its problems and start-up issues but lessons were learned and noted for future reference. Our cost for the softcover is \$10.40 per copy plus shipping, hardcover \$18.44 plus shipping. Shipping to the Storefront averages about \$1.00 per copy.

2011 R&I

The 2011 R&I is in process and I expect it to be out to the proof readers shortly.

In the 2011 R&I is new registration data for 1099 irises originating in 15 countries, with 55.1% of the total originating in North America (U.S. 598, Canada 7). Other countries represented are: Australia (155), Russia (96), France (59), Ukraine (37), U.K. (34), Germany (33), Italy (22), Czech Republic (21), New Zealand (14), Poland (11), Canada (7), Slovakia (5), China (4), Netherlands (3).

Of the 1099 new registrations, 63.8% are tall bearded, 24.1% other bearded types, and 12.1% beardless and species or species hybrids. Totals by class are as follows:
