


The 2015 Registrations and Introductions booklet was received by the AIS Storefront on April 22, 2016

Of the 1019 new registrations, 65.7% are tall beardeds, 20.7% other bearded types, and 13.7% beardless and species or species hybrids. Totals by class are as follows:

626	Tall Bearded (TB)	61.4%	18 Arilbred (AB)	1.8%
140	Standard Dwarf Bearded (SDB)	13.7%	16 Minature Tall Bearded (MTB)	1.6%

Page 24 of the "Handbook for Judges and Show Officials" paragraph 3 says:

"[An introduction is an offering for sale to the public by printed document such as a catalog or printed list, or by advertisement in the AIS Bulletin. However, to be eligible for AIS official awards above the level of High Commendation Award, the iris introduction must be recorded with the AIS Registrar.]
